## Parent Waiver Form and Medical Release

### **PARENT (GUARDIAN) WAIVER and PERMISSION TO AUTHORIZE MEDICAL SERVICES**

(Please read carefully and sign.)

I acknowledge that participation in RMD KIDz Camp 2024 involves risk to the Participant (and to Participant’s parents or guardians, if Participant is a minor), and may result in various types of injury including, but not limited to, the following: sickness, bodily injury, death, emotional injury, personal injury, property damage and financial damage. In consideration for the opportunity to participate in the activity described above (RMD KIDz CAMP 2024), the Participant (or parent/guardian if Participant is a minor) acknowledges and accepts the risks of injury associated with participation in and transportation to and from the Activity. The Participant (or parent/guardian) accepts personal financial responsibility for any injury or other loss sustained during the Activity or during transportation to and from the activity, as well as for any medical treatment rendered to the Participant that is authorized by the Sponsor or its agents, employees, volunteers, or any other representatives (collectively referred to hereinafter as the “Activity Sponsor”). Further, the Participant (or parent/guardian) releases and promises to indemnify, defend, and hold harmless the Activity Sponsor for any injury arising directly or indirectly out of the described Activity or transportation to and from the Activity, whether such injury arises out of the negligence of the Activity Sponsor, the Participant, or otherwise. If a dispute over this agreement or any claim for damages arises, the Participant (or parent/guardian) agrees to resolve the matter through a mutually acceptable alternative dispute resolution process. If the Participant (or parent/guardian) and the Activity Sponsor cannot agree upon such a process, the dispute will be submitted to a three -member arbitration panel for resolution pursuant to the rules of the American Arbitration Association.

I hereby give permission for the participant named above to participate fully in the program except as noted in participant’s application. In the event of illness or injury, I also give permission for the physician, dentist, or other health professional selected by the camp director to order such tests and treatments as are deemed necessary to safeguard the health of my child (the participant) and, in the event I cannot be reached in an emergency, I authorize the physician selected by the camp director to hospitalize, secure proper treatment for, and order injections and/or anesthesia and/or surgery for my child as named above. The camp nurse may administer over the counter medication as noted on camp registration.

Dear Pastor/Kids Camp Coordinator:

We are asking each church to designate one person to receive your camp registrations and to promote RMD Kidz Camp Masterpiece. Included in this packet is the camp information sheet and the links to our ONLINE registration forms. All registrations will be online this year!

**Please complete the spreadsheet included and send with your payment for all of your campers, as well as Signed Parent Release Forms and copies of Insurance Cards for each camper.** This will help us better know how much each camper has paid. If a child needs scholarship money from the district go ahead and send their registration with a note of how much scholarship money is needed. We do ask that each local church try and help with scholarship funding first, as our district funds are limited.

We are requesting full payment up front and BEFORE CAMP to eliminate processing payments at the campground and to help us facilitate some of our upfront costs. **All Registration Fees need to be postmarked by July 10th and made out to "RMD NDI"**, this will guarantee your campers S.W.A.G. Late Registrations will be taken until August 1, but with an additional Fee of \$25 per camper and will not guarantee S.W.A.G. For late Registrations please contact me.

We are also as always in need of camp staff! If you have anyone interested in coming to Camp Masterpiece this year they will find the links for Camp Volunteer Applications at our online links as well.

As part of our District Wide initiative to protect our RMD kids all Camp staff will be required to have completed a Rocky Mountain District Volunteer Application including a current (within the last 2 years) background check through NATSB and a certificate of completion of the Ministry Safe Training in order to participate in camp. Our District does have an account for both of these documents and links will be sent to the emails of those needing to complete these safety items. We would appreciate your church picking up the cost of these needed screenings, if you are unable to do so please contact me.

We look forward to seeing all of your children at camp this year.
